#### Introduction:

IL-10 (Interleukin 10, B cell derived T cell growth factor, B-TCGF, Cytokine synthesis inhibitory factor CSIF, T-cell growth inhibitory factor, TGIF) was originally described as Cytokine Synthesis Inhibitory Factor (CSIF) due to its ability to inhibit cytokine production by TH1 clones. IL-10 is expressed in activated CD8+ and CD4+ T cells, activated monocytes, mast cells, and Ly-1 B (in human cells). IL-10 shares over 80% sequence homology with the Epstein-Barr virus protein BCRFI that allows the virus to suppress the immune response. The functions of IL-10 include inhibition of macrophage-mediated cytokine synthesis, suppression of the delayed type hypersensitivity response, and stimulation of the TH2 cell response.

The BioLegend LEGEND MAX<sup>™</sup> High Sensitivity Human IL-10 ELISA Kit is a Sandwich Enzyme-Linked Immunosorbent Assay (ELISA) with a 96-well strip plate that is pre-coated with a monoclonal mouse anti-human IL-10 capture antibody. The detection antibody is a biotinylated monoclonal mouse anti-human IL-10 antibody. After washing away any unbound biotinylated detection antibody, a streptavidin-polymer HRP is used for detection. Streptavidin-Polymer HRP enhances the sensitivity of the kit, allowing for detection of low concentrations of IL-10. This kit is specifically designed for the accurate quantitation of human IL-10 in serum, citrate plasma, heparin plasma, cell culture supernatant, and urine. This kit is analytically validated with ready-to-use reagents.

## **Specimen Collection and Handling:**

Specimens should be clear and non-hemolyzed. If possible, unknown samples should be run at a number of dilutions to determine the optimal dilution factor that will ensure accurate quantitation.

<u>Serum</u>: Use a serum separator tube and allow clotting for at least 30 minutes, then centrifuge for 10 minutes at 1,000 x g. Remove serum layer and assay immediately or store serum samples at < -70°C. Avoid repeated freeze-thaw cycles.

<u>Plasma:</u> Collect blood samples in citrate- or heparin-containing tubes. Centrifuge for 10 minutes at 1,000 x g within 30 minutes of collection. Assay immediately or store plasma samples at < -70°C. Avoid repeated freeze-thaw cycles.

<u>Cell Culture Supernatant</u>: If necessary, centrifuge all samples to remove debris prior to analysis. It is recommended that samples be stored at < -70°C. Avoid repeated freeze-thaw cycles.

<u>Urine:</u> If necessary, centrifuge to remove debris prior to analysis. Samples can be stored at < -20°C. Avoid repeated freeze/thaw cycles.

#### Reagent and Sample Preparation:

Note: All reagents should be diluted immediately prior to use.

- Dilute the 20X Wash Buffer to 1X with deionized water. For example, make 1 liter of 1X Wash Buffer by adding 50 mL of 20X Wash Buffer to 950 mL of deionized water. If crystals have formed in the 20X Wash Buffer, bring to room temperature and vortex until dissolved.
- Reconstitute the lyophilized Human IL-10 Standard by adding the volume of Assay Buffer A to make the 20 ng/mL standard stock solution (Refer to LEGEND MAX Kit Lot-Specific Certificate of Analysis). Allow the reconstituted standard to sit at room temperature for 15-20 minutes, then briefly vortex to mix completely.
- 3. Dilute the 200X Human IL-10 Detection Antibody to 1X with Assay Buffer A.


For example, make 12 mL of 1X Detection Antibody by adding 60  $\mu L$  of 200X Detection Antibody to 11.94 mL of Assay Buffer A.

4. Dilute serum, citrate plasma, heparin plasma, and urine samples 1:2 in Assay Buffer A. The cell culture supernatant dilution factor should be determined by the end user; use Assay Buffer A for supernatant dilutions.

#### **Assay Procedure:**

**Note:** Do not mix reagents from different kits or lots. Reagents and/or antibodies from different manufacturers should not be used with this kit.

- 1. Bring all reagents to room temperature prior to use. It is strongly recommended that all standards and samples be run in duplicate or triplicate. A standard curve is required for each assay.
- 2. If not all microplate strips will be used, remove the excess strips by pressing up from underneath each strip. Place excess strips back in the foil pouch with the included desiccant pack and reseal.
- 3. Prepare 1000 µL of the 40 pg/mL top standard by diluting the appropriate amount of the standard stock solution in Assay Buffer A (refer to the LEGEND MAX<sup>™</sup> Kit Lot-Specific Certificate of Analysis). Perform six two-fold serial dilutions of the 40 pg/mL top standard in separate tubes using Assay Buffer A as the diluent. Thus, the human IL-10 standard concentrations in the tubes are 40 pg/mL, 20 pg/mL, 10 pg/mL, 5 pg/mL, 2.5 pg/mL, 1.25 pg/mL, and 0.625 pg/mL, respectively. Assay Buffer A serves as the zero standard (0 pg/ mL).




- 4. Wash the plate 4 times with at least 300 μL of 1X Wash Buffer per well and blot any residual buffer by firmly tapping the plate upside down on absorbent paper. All subsequent washes should be performed similarly.
- 5. Add 50  $\mu$ L of Assay Buffer A to each well that will contain either standard dilutions or samples. Then add 50  $\mu$ L of standard dilutions or samples to the appropriate wells.
- 6. Seal the plate with a plate sealer included in the kit and incubate the plate at room temperature with shaking for 2 hours.


- 7. Discard the contents of the plate into a sink, then wash the plate 4 times with 1X Wash Buffer as in step 4.
- 8. Add 100 μL of 1X Human IL-10 Detection Antibody to each well, seal the plate, and incubate at room temperature with shaking for 1 hour.
- 9. Discard the contents of the plate into a sink, then wash the plate 4 times with 1X Wash Buffer as in step 4.
- 10. Add 100  $\mu$ L of Streptavidin-Polymer HRP to each well, seal the plate, and incubate at room temperature with shaking for 30 minutes.
- 11. Discard the contents of the plate into a sink, then wash the plate 5 times with 1X Wash Buffer as in step 4. For this final wash, soak wells in 1X Wash Buffer for 30 seconds to 1 minute for each wash. This will help minimize background.
- 12. Add 100  $\mu$ L of Substrate Solution F to each well and incubate for 10 minutes **in the dark**.\* Wells containing human IL-10 should turn blue in color with an intensity proportional to its concentration. It is not necessary to seal the plate during this step.
- 13. Stop the reaction by adding 100  $\mu\text{L}$  of Stop Solution to each well. The solution color should change from blue to yellow.
- 14. Read absorbance at 450 nm within 15 minutes. If the reader is capable of reading at 570 nm, the absorbance at 570 nm can be subtracted from the absorbance at 450 nm.
- \* Optimal substrate incubation time depends on laboratory conditions and the optical linear ranges of ELISA plate readers.

#### **Assay Procedure Summary**

- 1. Wash 4 times. Add 50 μL Assay Buffer A.
- 2. Add 50  $\mu\text{L}$  of diluted standards or samples. Incubate 2 hours, RT with shaking.





 Wash 4 times. Add 100 μL 1X Detection Antibody. Incubate 1 hour, RT with shaking.



 Wash 4 times. Add 100 μL Streptavidin-Polymer HRP. Incubate 30 minutes, RT with shaking.







- 6. Add 100  $\mu L$  Stop Solution.
- 7. Read absorbance at 450 nm and 570 nm.


#### **Calculation of Results:**

The data can be best calculated with computer-based curve-fitting software using a 5- or 4-parameter logistics curve-fitting algorithm. If an appropriate software is not available, use log-log graph paper to determine sample concentrations. Determine the mean absorbance for each set of duplicate or triplicate standards, controls, and samples. Plot the standard curve on log-log graph paper with analyte concentration on the X-axis and absorbance on the Y-axis. Draw a best fit line through the standard points. To determine the unknown analyte concentrations, find the mean absorbance value of the unknown concentration on the Y-axis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the X-axis and read the analyte concentration.

If samples were diluted, multiply the concentration by the appropriate dilution factor. If a test sample's absorbance value falls outside the linear portion of the standard curve, the test sample needs to be re-analyzed at a higher (or lower) dilution as appropriate.

#### **Typical Data:**

This standard curve was generated at BioLegend for demonstration purposes only. A standard curve must be run with each assay.



#### **Performance Characteristics:**

<u>Specificity</u>: No cross reactivity was observed when this kit was used to analyze recombinant human IL-20, human IL-22, human IL-28A, human IFN- $\lambda$ 1, and mouse IL-10 at 50 ng/mL. No significant interference by these proteins was observed.

Sensitivity: The minimum detectable concentration of IL-10 is 0.171 pg/mL.

<u>Recovery:</u> Recombinant human IL-10 was spiked into serum (diluted 1:2), plasma (diluted 1:2), urine (diluted 1:2), and undiluted cell culture supernatant (from unstimulated PBMCs) at three different concentrations. Then, sample recovery was analyzed with the LEGEND MAX<sup>TM</sup> High Sensitivity Human IL-10 ELISA kit.

<u>Linearity:</u> Serum (diluted 1:2), plasma (diluted 1:2), and urine (diluted 1:2) samples were spiked with cell culture supernatant (from PBMCs stimulated with 1 µg/mL LPS for 2 days). This supernatant (diluted 1:100) was also tested for linearity. The samples were serially diluted two-fold to produce samples with concentrations within the dynamic range. Then, linearity was analyzed with the LEGEND MAX<sup>™</sup> High Sensitivity Human IL-10 ELISA kit.

## **Troubleshooting Guide:**

Problem	Probable Cause	Solution
High Background	Background wells were contaminated	Avoid cross-well contamination by using the provided plate sealers.
		Use multichannel pipettes and change tips between pipetting samples and reagents.
	Insufficient washes	Increase number of washes. Increase soaking time between washes prior to addition of substrate solution.
	TMB Substrate Solution was contaminated	TMB Substrate Solution should be clear and colorless prior to addition to wells. Use a clean container prior to pipetting substrate solution into wells.
No or poor signal	Detection Antibody, Avidin-HRP or Substrate solution were NOT added	
	Wrong reagent or reagents were added in wrong sequential order	Rerun the assay and follow the protocol.
	Insufficient plate agitation	The plate should be agitated during all incubation steps using a plate shaker at a speed where solutions in wells are within constant motion without splashing.
	The wash buffer contains Sodium Azide (NaN3)	Avoid Sodium Azide contamination in the wash buffer as it inhibits HRP activity.
	Incubations were done at an inappropriate temperature, timing or without agitation	Rerun the assay and follow the protocol.
Low or poor standard curve	The standard was incorrectly reconstituted or diluted	Adjust the calculations and follow the protocol.
signal	Standard was inappropriately stored	Store the reconstituted standard stock solution in polypropylene vials at -70°C. Avoid repeated freeze-thaw cycles.
	Reagents added to wells with incorrect concentrations	Check for pipetting errors and the correct reagent volume.
