<b>Description</b>	CD11c is a 145-150 kD type I transmembrane glycoprotein also known as integrin $\alpha$ and CR4. CD11c non-covalently associates with integrin $\beta$ (CD18) and is expressed on monocytes/macrophages, dendritic cells, granulocytes, NK cells, and subsets of T and B cells. CD11c has been reported to play a role in adhesion and CTL killing through its interactions with fibrinogen, CD54, and iC3b.

<b>Formulation</b>	Phosphate-buffered solution, pH 7.2, containing 0.09% sodium azide and 0.2% (w/v) BSA (origin USA).
<b>Preparation</b>	The antibody was purified by affinity chromatography, and conjugated with PE under optimal conditions.
<b>Concentration</b>	150 µg/mL
<b>Storage &amp; Handling</b>	The antibody solution should be stored undiluted between 2°C and 8°C and protected from prolonged exposure to light. <b>Do not freeze.</b>

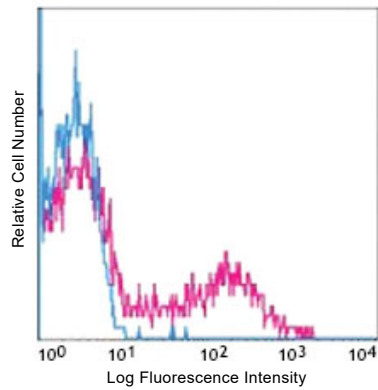
